Authorization is requested to enter into a lease agreement with Alclear, LLC (CLEAR) for approximately 571 square feet (SF) of office and breakroom space located at the Pittsburgh International Airport (PIT). The term of the lease will commence upon the date of beneficial occupancy (DBO) of the terminal modernization program (TMP) and continue through November 14, 2028. The term will continue on a month-to-month basis thereafter. The annual revenue will be approximately \$197,092.07, for a total revenue of \$591,276.20.
