II. 1026-25 PNC Bank Line of Credit @

Authorization is requested to enter into a new \$10,000,000 revolving line of credit with PNC Bank, N.A. This unsecured facility will provide short-term liquidity and bridge the timing of grant expenses and subsequent reimbursements. The line will have a two-year term, allowing the ACAA to borrow, repay, and re-borrow funds as needed throughout the period. Loans under this Credit Facility will bear interest at a per-annum rate equal to the One-Month Secured Overnight Financing Rate (SOFR) plus 75 basis points (0.75%). The revolving line is expected to mature on or around December 16, 2027.
